# Comments

The Mid-America Chapter, HPS, arranged for a DOT refresher webinar in June 2014. We have members of the chapter attending, but more that aren't. At this last one, the chapter contracted with Dade Moeller training academy for a repeat of the DOT webinar, and provided 12 individuals in the chapter boundaries who would be interested; (their minimum for putting together a webinar). Apparently there were far more individuals than just the Mid-America Chapter attending, from different areas of the US. This proved to the Program Chair that webinars are useful ways of holding technically oriented meetings. We were going to have a chapter-only webinar (one hour) in the springtime, highlighting the President- Elect's talk, but due to scheduling for non-technical obligations by a couple of the officers, it didn't get done. The Program Chair attended one of the webinars the HPS ran out of the HQ office, though, and was moderately satisfied. The format can be recommended for a bunch of HPs who don't have a lot of time to travel, but have time to sit and eat lunch(or supper) in front of a computer screen at work--or something similar. Keep it to no more than 90 minutes, though. The chapter's experience with the webinar- DOT format bears this out. Our first try at a DOT webinar several years ago was an all-day affair. Not easy. The subsequent ones--breaking the material into a couple or three shorter presentations--is far easier on everyone. (A word to the wise...)
