2022 Update: MidAmerica Chapter, HPS did not hold meetings, virtual or otherwise, in 2021, or in 2022 or so far in 2023. Pandemic, work and personal time constraints and retirements for half of our program committee definitely impacted this. The previous 3 zoom! meetings were as follows:

Dec. 15, 2020-- The Midwest Chapter, HPS invited us to their HP trivia night! THere were about 11 attendees total (both chapters). The topic was Medical Health Physics.It was an excellent experience for those of us attending!

October 21, 2020 Meeting. Started our Zoom platform noon "Lunch and Learn" Technically oriented hour long seminars again with the Regulatory Update session for the year. State regulators were asked to provide regulatory updates for their state. Speakers were: Becki Harisis, NE Radioactive Materials, Ben Ashman, NE X-Ray Program, James Uhlmeyer, KS programs, and John Langston, MO Radiation Producing Device program. NE and KS are Agreement States, MO is not. This was a well-attended session! It, as well as the previous two meetings, are available for viewing by chapter members on a moderated YouTube channel after the session. October is planned as a stronger interest topic for the region and we hope to draw more individuals to that.
