Comments

The CRMCHPS has been working closely with its Colorado State University Student Branch in selecting topics and speakers, often sharing speakers (on different topics) between the CRMC evening dinner meeting and the daytime CSU HP Program guest lecture series. The CRMC also has met jointly with the NIOSH Mountain and Plains Education and Research Center and invited local NRRPT Registrants to attend its meetings. Dr. Thomas E. Johnson, CSU, has videotaped some of these lectures and they are available on the HPS Chapters Web site for downloading and viewing. The CRMC and CRMC CSU Student Branch will pursue AAHP Certification credits for viewing these lectures. In February 2010, the Pres-elect of the CRMCHPS, Nancy Daugherty, attended a meeting sponsored by the local section of the ANS in which 18 speakers gave 5-minute presentations regarding nuclear issues for a representative of Senator Mark Udall's office. Daugherty

presented an introduction to the Health Physics Society and to the HPS Web site. She presented a hard copy letter from HPS President Howard Dickson inviting Sen. Udall to use the HPS as a resource for information regarding radiation protection. The April 2010 CRMCHPS Annual Technical Meeting, attended by 40 members, capped off a very successful meeting year in which evening meetings were resumed and a wide variety of topics were addressed.
