The Executive Committee met approximately once a month to discuss business and plan chapter meetings.

The membership statistics supplied in this report refer to plenary, emeritus, affiliate, and student members who are up-to-date with their membership dues. I obtained HPS membership and certification statistics by cross-referencing our roster with the HPS Directory and ABHP 2016 listing. Our chapter has a contact list of 251 who we consider "active" and to whom we regularly send meeting and other announcements.

Three short newsletters were distributed to our contact list (Nov' 16, Mar '17, May '17). We aim for one more newsletter in June to summarize the chapter year.

We continue to regularly maintain our chapter website: http://bwchps.wildapricot.org . Meeting announcements are posted online and members can pay their registration fees and membership dues through the website. Speaker slides were uploaded to our "members only" area after each meeting. Our website also has a chapter newsletter archive dating back to 1958.

The chapter finished putting together 3 radiation survey meter demonstration kits. We aim to use these for education instruction, workshops, and public outreach in coming year.

Our CHP Certification Review course was canceled again this year because there was nobody willing to lead the instruction. Good news is we have identified someone for next year. We expect to hold the course next year pending sufficient interest from our membership.
